

Preparing the charger

KX-PRXA10

- Insert the AC adaptor plug to the unit until you hear a click.
- (2) Connect the AC adaptor to the power outlet.



Note:

- Use only the supplied Panasonic AC adaptor PNLV226K.
- The AC adaptor must remain connected at all times. (It is normal for the adaptor to feel warm during use.)

Preparing the handset


Inserting microSD card and the battery

A microSD card (not supplied) allows you to expand the handset's storage capabilities.

Important:

- Use only the supplied battery. For replacement, use only the Panasonic rechargeable battery noted on page 2.

- When removing the battery, make sure you turn off the handset first.
- To avoid loss of data or malfunction, do not damage, carelessly handle, or short-circuit the gold-colored contacts of the microSD card.
 - 1 Remove the handset's cover.
 - 2 Open the microSD card cover by sliding it toward the nearest side of the handset (①) and then lifting up (②).
 - 3 Insert the microSD card with the gold-colored contacts facing down, close the microSD cover (①), and then gently slide the cover toward the opposite side of the handset (②).



5 Attach the cover.

Note:

• If the battery is fully charged, but the operating time seems to be shorter, clean the charge contacts of the handset and charger with a dry cloth and charge again.

Charging the handset

Charge the handset for about 5 hours before initial use. The charge indicator () lights while the handset is charging and turns off when the handset is fully charged.

Important:

 If the handset is placed into the charger while talking on the phone, the call is not disconnected.

Place the handset into the charger.

Connect a USB cable (not supplied) directly to the handset.

Turning on the handset

To turn the handset on, press and hold the power button on the top of the handset.

Setup wizard

The first time you turn on the handset, the setup wizard prompts you to configure initial settings such as the display language. Follow the on-screen instructions to configure the handset.

Registration dialog

While using the setup wizard, a dialog may be displayed prompting you to press the **(**•**))** on the base unit for 5 seconds. Follow the on-screen instructions to register the handset to the base unit. When registration is complete, continue to follow the setup wizard.

Registering the handset to the base unit

If the handset is not registered, the registration dialog (page 4) is displayed. Follow the on-screen instructions to register the handset to the base unit. If you cancel this dialog, you can display it again by tapping **[Landline]** in the home screen or app list, and then tapping **[Landline settings]** \rightarrow **[Initial settings]**.



Preparación del cargador

KX-PRXA10

- Inserte el enchufe del adaptador de corriente en la unidad hasta que escuche un clic.

Preparación del auricular


Cómo insertar la tarjeta micro SD y la batería

La tarjeta micro SD (no incluida) le permite expandir la capacidad de almacenamiento del auricular.

Importante:

 Use solo la batería que se suministra. Para reemplazarla, use solo la batería recargable Panasonic que se especifica en la página 2.

- Al remover la batería, asegúrese de apagar primero el auricular.
- Para evitar la pérdida de datos o una falla de funcionamiento, no dañe, manipule descuidadamente ni provoque un corto circuito en los contactos dorados de la tarjeta micro SD.
 - 1 Retire la cubierta del auricular.
 - 2 Abra la cubierta de la tarjeta micro SD deslizándola hacia el lado más cercano del auricular (①) y después levántela (②).
 - 3 Inserte la tarjeta micro SD con los contactos dorados hacia abajo. Cierre la cubierta de la tarjeta micro SD (①), y después deslícela cuidadosamente hacia el lado opuesto del auricular (②).
 - 4 Inserte la batería (①) y colóquela en el auricular (②).
 - 5 Coloque la cubierta.

 Si la batería está completamente cargada, pero el tiempo de funcionamiento parece ser más corto, limpie los contactos de carga del auricular y del cargador con un paño seco y cárguela de nuevo.

Cómo cargar el auricular

Cargue el auricular aproximadamente 5 horas antes de usarlo por primera vez. El indicador de carga (①) se ilumina mientras el auricular se está cargando, y se apaga cuando está completamente cargado.
